CLIENT AGREEMENT

Client agrees that employees of The Temp Connection shall not be entrusted with unattended premises, cash, negotiables or other valuables or authorize such employees to operate machinery or motor vehicles without written permission from The Temp Connection and further agrees that The Temp Connection shall not be responsible for any loss or damage caused by The Temp Connection employees operating client's owned or leased motor vehicle(s), and Client therefore accepts full responsibility for claims, including defense thereof, involving bodily injury, property damage, fire, theft, collision, cargo damage or public liability damage sustained or incurred as a result of a Temp Connection employee driving such vehicle(s) or arising out of or involving violation by Client of the above. The Temp Connection is not responsible for claims made under its fidelity bond unless such claims are reported in writing to it by Client within fifteen (15) days after discovery of the occurrence. Client will indemnify and save The Temp Connection harmless from claims and demands arising out of the Occupational Safety and Health Act as it relates to premises owned or controlled by Client and to which The Temp Connection's employees are assigned.

Client recognizes the employer-employee relationship of The Temp Connection and accepts the obligation to discuss all matters concerning employment, job assignment, pay procedures and other matters. Client agrees that should their company wish to hire the employee of The Temp Connection on a permanent basis, Client will communicate this intent and keep the assigned employee on the payroll of The Temp Connection for a period mutually agreed upon by the Client representative and The Temp Connection or pay a service fee mutually agreed upon by the representatives of both parties.

The Temp Connection shall indemnify and save Client harmless from claims and demands related to withholding taxes, Social Security and Medicare taxes due under federal and state law. If Client fails to timely pay any amounts due for work performed by the employee, The Temp Connection shall have all rights, privileges and remedies available in an action to recover monies owed under state and federal law. In addition, a 1.5% per month (18% per annum) rebilling charge will be applied to the unpaid balance after 30 days. If The Temp Connection is required to engage the services of an attorney or collection agency to recover any amounts due and unpaid, it shall also be entitled to recover the full amount of any fees incurred.
